The necessity of revenue for the support of the government does not admit of the delay attendant upon proceedings in a court of justice, and they are not required for the enforcement of taxes or assessments.'32 As between ad valorem taxes and specific taxes, it undoubtedly takes more in the way of notice and hearing to satisfy the requirement of due process of law in the case of the former than it does in the case of the latter. The position of the Supreme Court of the United States regarding this matter cannot be stated better than by quoting its own words: "Of the different kinds of taxes which the state may impose," says that court, "there is a vast number of which, from their nature, no notice can be given to the taxpayer, nor would notice be of any possible advantage to him, such as poll taxes, license taxes (not dependent upon the extent of his business) and generally, specific taxes on things or persons or occupations. In such cases the legislature, in authorizing the tax, fixes its amount, and that is the end of the matter. If the tax be not paid, the property of the delinquent may be sold and he be thus deprived of his property. Yet there can be no question, that the proceeding is due process of law, as there is no inquiry into the weight of evidence, or other element of a judicial nature, and nothing could be changed by hearing the taxpayer. No right of his is, therefore, invaded....
